Information on Club Activities

Sanctions

Sanctions are required for skaters to compete in overseas events. It confirms the skater as a registered member of the NZFRS. Applications for sanction are to be sent from Club Secretaries to the Sports Committee who will then forward to the National Office.

Information required with the request: The Skater concerned, Event Name, Where it is and The Timeframe they will be overseas. Please allow two weeks for this to be processed.

Permits

Permits are required for events to be held in order to be covered by the NZFRS and Sports Committee policies and use of federated Officials. For speed this also allows for the time to count for National Qualification.

The organisers should submit the permit as soon as the competition date has been set, as per Policy 1.09 to ensure sufficient time to eliminate clashes of dates. Emailed forms & Electronic Payment are accepted. Once a permit is issued, the competition will be loaded on the SkateNZ website. Permits will not be issued until payment is received.

Registrations

Registrations are required for all skaters to compete in Federated Grades at NZFRS events. It is the Club Secretaries responsibility to ensure that skaters are appropriately registered.

The registration period is 1 July – 30 June and re-registrations for the next season are sent in May.

- ❖ Discounts are given for renewals prior to 1 July.
- ❖ Re-Registrations received between 1 July - 1 February are the full renewal fee. Registrations for new skaters received during this timeframe are the discounted rate.
- ❖ After 1 February the registration amount reduces to 60% of the applicable fee (i.e. \$48 for Class 1 Renewal, \$39 for Class 1 New Skater).
- ❖ After 1 April a New Skater registration where they will only compete in one event before the next renewal period the registration amount is \$20.
