OSCAR NOMINATIONS - SPEED

OBJECTIVES:

To ensure that members are aware of the nomination process for the selection of the Speed OSCAR awards.

PROCEDURES:

1. Oscar nominations are considered for the most outstanding performance at the NZ Speed [Road and Flat Track] Championships. Nominations can be for the following categories:
 - Individual skaters or relay teams.
2. This prestigious award is decided by the NZFRS Board Members and the Championship Manager from written nominations, received from any registered member and must be signed by an official or Team Manager.
3. In making nominations and considering selections, it is important to consider what makes up an outstanding performance. One which can be measured both objectively and subjectively.
 - Firstly, it can be by the margin of superiority over the rest of the field, or the shattering of a long standing record.
 - More subjectively, it can be a spectacular, crowd pleasing performance that catches the imagination of the spectators.
 - It also can be a performance that shows great courage or sportsmanship under pressure or stress.
 - An outstanding performance can be an unusual expression of sheer power and speed.
4. While recognising that different events have different characteristics, an outstanding performance is one that must be truly memorable in the eyes of the judges and officials, spectators and fellow competitors.
5. An outstanding performance is one that sets the crowd abuzz and is felt as well as seen.
6. **OSCARS** should not be awarded merely on the basis of the number of medals won, although this may be a relevant consideration in some circumstances.
7. In making awards, NZ Speed Championship Committee will make a small citation demonstrating the reasoning behind their decision.
